#### Semi Husked Coconut

#### Copra

Copra is the desiccated flesh of carefully selected fresh coconut.

The selected ripe coconuts split into two, continued by driving them under the sun

to detach them from their shells, arranged on special shelves for the final drying process

afterward. Until lastly packed and ready to be produced as materials for various advanced products



#### **Coconut Fiber**

Coir is a natural fiber formed by the outer part of the coconut shell, The fibrous material can be seen between the hard shell, the inner part, and the outer layers of coconut

There are two types of coconut coir that possess different usages:

- Brown Coconut fiber Produced from ripe coconut, this fiber can be utilised as a material for upholstery, sacks, and horticulture
- White Coconut Fiber Produced from raw coconut, one is used to make fine brushes, fishing nets, and lastly ropes.





#### Crude Coconut Oil (CCO)

Crude Coconut oil is the raw coconut oil made of Copra extraction; these mature dried coconut flesh must be further processed to be applicable for usage in the food, soap, cosmetic and oleochemical industries



#### RBD Coconut Oil (RBD-CNO)

Is the refined version of Crude Coconut oil tha is suitable for consumption. RBD CNO

is a bright yellow liquid and is semi-solid under room temperature. These kinds of coconut oil

are used for food processing and in the oleochemical industries. CNO is relatively more resistant towards high temperatures,

therefore lasts longer, and is hard to be blackened during the cooking process



#### Virgin Coconut Oil (VCO)

Is an oil that is extracted purely from fresh coconut milk, processed through significantly different stages from the other coconut oil, also smelled of pure fresh coconut water. Although mainly the content of coconut oil has no difference compared to VCO, this product has more advantages, one of which is vitamin E wich works best for facial and skin care. VCO is also suitable for consumption: noticing this product is free of trans fa

is also suitable for consumption; noticing this product is free of trans fat and not hydrogenated





#### **Desiccated Coconut**

Desiccated Coconut is obtained by drying the granualated or shredded white meat of the fresh mature coconut kernel. It should be suitably processed for human consumption.

Desiccated Coconut using the aqueous process by pressing the meat to obtain coconut cream before drying shall be classified as low fat desiccated coconut.

Desiccated Coconut is classified for the purposes of commercialization into three types according to the granulometry of the product as follows:

- Extra-fine desiccated coconut
- Fine desiccated coconut
- Medium desiccated coconut



#### **Coconut Milk & Cream**

Coconut Milk and Cream are made by boiling the coconut meat with water. As might be expected, the difference between milk and cream is in the concentration and consistency.

- Coconut milk has the liquid consistency of cow's milk and is made from simmering one part shredded coconut in one part water. Coconut milk is the basis of most Thai curries.
- Coconut cream is much thicker and richer. It is made from simmering four parts shredded coconut in one part water. The cream that rises to the top of a can of coconut milk is also considered coconut cream.



#### **Organic Coconut Sugar**

Coconut sugar is the crystallized nectar of the coconut palm tree blossom that (Cocos nucifera) made by a simple boiling, cooling, and grinding process. It has been used as sugar in South-East Asia for many centuries, most particularly in Indonesia. Our Organic Coconut Sugar is made by a community of traditional coconut farmers in Indonesia and processed naturally which there is no chemicals and preservatives added.
